## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS** (this "Termination"), dated as of December 22, 2015 is made by Abacus Finance Group, LLC in its capacity as Agent (as defined in the Collateral Agreement referred to below) for itself and the other Secured Parties (as defined in the Collateral Agreement), in favor of LDISCOVERY, LLC, a Delaware limited liability company ("LDisc"), RENEW DATA CORP., a Delaware corporation ("RDC"), and LDISC HOLDINGS, LLC, a Delaware limited liability company ("Holdings") (each a "Grantor" and together, the "Grantors"). Unless otherwise defined herein or the context otherwise requires, terms used in this Termination shall have the meanings assigned to such terms in the Collateral Agreement (as defined below). Notwithstanding the foregoing, for the purposes of this Termination, "Trademark Collateral" shall have the meaning assigned to such term in each of the Trademark Security Agreements, as applicable, and shall include, without limitation, those Trademark registrations and Trademark applications listed on Schedule 1 attached hereto.

**WHEREAS**, pursuant to (i) that certain Amended and Restated Guarantee and Collateral Agreement, dated as of November 13, 2014 (as it has been amended, restated, supplemented, waived or otherwise modified through the date hereof, the "Collateral Agreement") between the Grantors, the Agent and other parties thereto, (ii) that certain Trademark Security Agreement, dated as of August 14, 2015, executed by LDisc, as Grantor, in favor of the Agent (the "LDisc August 2015 TSA"), (iii) that certain Trademark Security Agreement, dated as of July 31, 2015, executed by RDC, as Grantor, in favor of the Agent (the "LDisc July 2015 TSA"), (iv) that certain Trademark Security Agreement, dated as of November 13, 2014, executed by LDisc, as Grantor, in favor of the Agent (the "LDisc November 2014 TSA"), (v) that certain Trademark Security Agreement, dated as of November 13, 2014, executed by RDC, as Grantor, in favor of the Agent (the "RDC November 2014 TSA"), and (vi) that certain Trademark Security Agreement, dated as of September 30, 2011, executed by Holdings, as Grantor, in favor of the Agent (the "Holdings September 2011 TSA" and together with the LDisc August 2015 TSA, the LDisc July 2015 TSA, the LDisc November 2014 TSA and the RDC November 2014 TSA, the "Trademark Security Agreements"), the Grantors pledged and granted to the Agent a continuing security interest in and Lien upon all of the Grantors' right, title and interest in, to and under the Trademark Collateral;

**WHEREAS**, the security interest in the Trademark Collateral pledged and granted by LDisc to the Agent under the LDisc August 2015 TSA was recorded at the United States Patent and Trademark Office on September 1, 2015, at Reel 005613 and Frame 0665;

**WHEREAS**, the security interest in the Trademark Collateral pledged and granted by LDisc to the Agent under the LDisc July 2015 TSA was recorded at the United States Patent and Trademark Office on August 13, 2015, at Reel 005599 and Frame 0375;

**WHEREAS**, the security interest in the Trademark Collateral pledged and granted by LDisc to the Agent under the LDisc November 2014 TSA was recorded at the United States Patent and Trademark Office on November 13, 2014, at Reel 005400 and Frame 0883;

**WHEREAS**, the security interest in the Trademark Collateral pledged and granted by RDC to the Agent under the RDC November 2014 TSA was recorded at the United States Patent and Trademark Office on November 13, 2014, at Reel 005400 and Frame 0873;

**WHEREAS**, the security interest in the Trademark Collateral pledged and granted by Holdings to the Agent under the Holdings September 2011 TSA was recorded at the United States Patent and Trademark Office on October 6, 2011, at Reel 004637 and Frame 0294; and

**WHEREAS**, the Agent has agreed to terminate, release and discharge its security interest in and Lien on all of the Trademark Collateral; and

**NOW, THEREFORE**, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities of the Grantors secured by the Trademark Collateral pursuant to the Collateral Agreement and the Trademark Security Agreements, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby absolutely, unconditionally and irrevocably terminates, cancels, releases and forever discharges all of its Liens upon and security interests in all of the Grantors' right, title and interest in, to and under the Trademark Collateral, including all goodwill associated with the Trademark Collateral, and any and all other security interests or liens that the Agent or its predecessors, successors, assigns and transferees may have in or to the Trademark Collateral under the Collateral Agreement or the Trademark Security Agreements.

2. The Agent authorizes and requests that the United States Commissioner of Patents and Trademarks and any other applicable officer in any successor office or any similar office in any other country record this Termination.

3. THIS TERMINATION AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS TERMINATION SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK.
