NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

(Trademarks, Trademark Registrations,
Trademark Applications and Trademark Licenses)

December 18, 2015

WHEREAS, EB IP Holdings LLC, a Delaware limited liability company (herein referred to as the “Grantor”) owns, or in the case of licenses is a party to, the Trademark Collateral (as defined below); and

WHEREAS, EmployBridge, LLC (formerly known as Koosharem, LLC) (the “Company”), the other Borrowers party thereto, the Grantor, the other Guarantors party thereto, the Lenders party thereto, Royal Bank of Canada, as U.S. Administrative Agent and U.S. Collateral Agent, and others are parties to that certain Credit Agreement dated as of May 16, 2014 as amended by the First Amendment and First Incremental Amendment dated as of February 9, 2015 and supplemented by Joinder No.1 to the Credit Agreement dated as of February 9, 2015 (as further amended and/or supplemented from time to time, the “Credit Agreement”); and

WHEREAS, pursuant to (i) a U.S. Guarantee and Collateral Agreement dated as of May 16, 2014 as supplemented by the Security Agreement Supplement dated as of December 22, 2014, the Security Agreement Supplement dated as of February 9, 2015 and the Security Agreement Supplement No. 2 dated as of December 18, 2015 (as further amended and/or supplemented from time to time, the “Security Agreement”) among the Company, the other Borrowers party thereto, the Grantor, the other Guarantors party thereto and Royal Bank of Canada, as U.S. Administrative Agent and U.S. Collateral Agent for the Secured Parties referred to therein (in such capacity, together with its successors in such capacity, the “Grantee”), and (ii) certain other Security Documents (including this Notice of Grant of Security Interest in Trademarks), the Grantor has guaranteed the Obligations of the Borrowers and the Guarantors, as applicable, and secured such guarantee by granting to the Grantee for the benefit of such Secured Parties a continuing security interest in personal property of the Grantor, including all right, title and interest of the Grantor in, to and under the Trademark Collateral (as defined below); and

WHEREAS, capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Security Agreement (or, if not defined therein, in the Credit Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor, in order to secure all Obligations, hereby grants to the Grantee, for the benefit of the Secured Parties, a continuing security interest in all of the Grantor’s right, title and interest in, to and under all of the following property of such Grantor, as the case may be, whether now owned or

existing or hereafter acquired or arising and regardless of where located (collectively, the “Trademark Collateral”): (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, brand names, trade dress, domain names, global top level domain names, and any other source or business identifiers protected under the laws of the United States or any State thereof or any other country or political subdivision thereof, (ii) the goodwill of the business symbolized thereby or associated therewith, (iii) all registrations and applications therefor, including registrations and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, including those referred to in Schedule 1 hereto; and (iv) all renewals of any of the foregoing; provided, that no security interest shall be created in, and the term “Trademark Collateral” shall not include any Excluded Assets; provided, further that the foregoing security interests shall immediately attach to, and the Trademark Collateral shall immediately include, any such asset (or portion thereof) upon such asset (or such portion) ceasing to be an Excluded Asset. For the avoidance of doubt, no security interest shall be granted in any United States intent-to-use Trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use Trademark applications under applicable federal law.

The foregoing security interest is granted in conjunction with the security interests granted by the Grantor to the Grantee pursuant to the Security Agreement and is expressly subject to the terms and conditions thereof. The Grantor acknowledges and affirms that the rights and remedies of the Grantee with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein and which shall override the terms hereof in the event of a conflict.

This Notice of Grant of Security Interest in Trademarks has been executed and delivered by the Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office (and any successor office).

This Notice of Grant of Security Interest in Trademarks may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Notice of Grant of Security Interest in Trademarks by facsimile or other electronic imaging shall be effective as delivery of a manually executed counterpart of this Notice of Grant of Security Interest in Trademarks.






