Assignor agrees to execute such further papers and do such other acts as may be necessary to obtain or assign the aforementioned trademarks and the Scheduled Marks, including but not limited to, any acts which may be necessary, desirable or convenient for claiming said priority rights and perfecting Assignee’s title in the Scheduled Marks.
