This Assignment shall be binding upon and inure to the benefit of the parties hereto, and their permitted successors in interest and assigns.



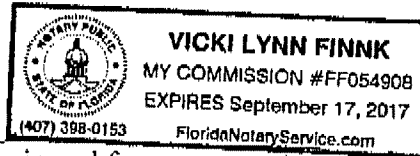
