Secured Party also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Grantor may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of Texas without regard to conflicts of law principles.
