PARTIAL RELEASE OF PATENT AND TRADEMARK SECURITY INTEREST

WHEREAS, the Administrative Agent wishes to release its interest in the Patents and Trademarks listed on Schedule A only, and retransfer and reassign to the Grantor without recourse all of the Administrative Agent's right, title and interest in and to the Patents and Trademarks listed on Schedule A.

NOW THEREFORE, the Administrative Agent hereby releases any security interest it may have in the Patents and Trademarks listed on Schedule A only, including any goodwill of the business symbolized by the foregoing, and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Grantor.
