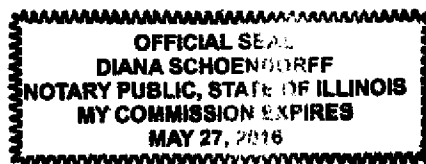

REAFFIRMATION OF LOAN DOCUMENTS

This REAFFIRMATION OF LOAN DOCUMENTS, dated as of November 8, 2013 (this "Agreement"), is made and given by HY CITE CORPORATION, a Wisconsin corporation ("Hy Cite"), HY CITE ENTERPRISES, LLC, a Wisconsin limited liability company (formerly Hy Cite Enterprises, Inc.; "Enterprises-LLC"), ROYAL CHARM, LTD., a Wisconsin corporation ("Royal Charm"), INSTORE CORPORATION, a Wisconsin corporation ("InStore"), HCC AVIATION, LLC, a Wisconsin limited liability company ("Aviation"; together with Hy Cite, Enterprises-LLC, Royal Charm and InStore each individually, a "Borrower" and collectively, the "Borrowers"), HCCBA, LLC, a Wisconsin limited liability company ("HCCBA"), HCCBZI, LLC, a Wisconsin limited liability company ("HCCBZI") and HCCBZII, LLC, a Wisconsin limited liability company ("HCCBZII" and together with HCCBA and HCCBZI each individually, a "Guarantor" and collectively, the "Guarantors") in favor of ~~FIFTH THIRD BANK, an Ohio banking association, as collateral and administrative agent for the Lenders (the "Agent").~~ PNC Bank, National Association *WCE*

RECITALS

A. The Borrowers, the Guarantors, the Lenders and the Agent are parties to an Amended and Restated Revolving Credit Loan and Security Agreement dated as of November 22, 2011 (as amended, restated, supplemented, and otherwise modified from time to time prior to the date hereof, the "Existing Credit Agreement").

B. The Borrowers, the Guarantors, the Lenders and the Agent have agreed to amend and restate the Existing Credit Agreement, which shall continue the revolving credit and letter of credit facilities to the Borrowers, and the Lenders are willing to do so on the terms and conditions set forth in that certain Second Amended and Restated Revolving Credit Loan and Security Agreement dated as of the date hereof (as further amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Second Amended and Restated Credit Agreement") between the Borrower, the Lenders and the Agent.

AGREEMENT

NOW, THEREFORE, for and in consideration of the mutual covenants, conditions, stipulations, and agreements set forth herein and in the Second Amended and Restated Credit Agreement and the other Loan Documents, and other valuable consideration, the receipt of which is hereby acknowledged, the undersigned hereby consent and agree as follows:

1. Capitalized terms used in this Agreement but not otherwise defined shall have the meanings ascribed to them in the Second Amended and Restated Credit Agreement.
2. The Borrowers and the Guarantors confirm to the Lenders and the Agent that all of the terms, conditions, provisions, agreements, requirements, promises, obligations, duties and covenants of the undersigned under the Loan Documents listed on Exhibit A ("Reaffirmed

Documents”) to which any of the undersigned is a party, and any and all other documents and agreements entered into with respect to the obligations under the Existing Credit Agreement as modified hereby, are hereby ratified and affirmed in all respects.

3. The Borrowers and Guarantors represent and warrant to Agent and the Lenders that:

a. Each of the Reaffirmed Documents is a valid and binding agreement as of the date hereof and all obligations of the Borrowers and Guarantors thereunder are in full force and effect in respect of the Existing Credit Agreement and continue and shall be in full force and effect in respect of the Second Amended and Restated Credit Agreement, as if executed and delivered in connection therewith. The parties acknowledge that the reaffirmation of the Reaffirmed Documents set forth herein is a convenience to facilitate entering into the Second Amended and Restated Credit Agreement and but for this Agreement, Agent and the Lenders would not enter into the Second Amended and Restated Credit Agreement.

b. Each of the schedules and exhibits to the Reaffirmed Documents is true, correct, and complete in all material respects as of the date hereof.

c. After giving effect to this Agreement, all Obligations and all covenants, representations and warranties of the Borrowers and Guarantors set forth in the Reaffirmed Documents to which the Borrowers and Guarantors are a party are true and correct in all material respects, without duplication as to any materiality modifiers, qualifications, or limitations set forth therein and as of the Restatement Date (except for those representations and warranties made as of an earlier date, which shall be true and correct in all material respects as of such earlier date or with such changes as are permitted by the Second Amended and Restated Credit Agreement), with the same force and effect as if made on such date.

4. Consent. Borrowers and Guarantors hereby authorize Agent to update Schedule A to each of the (i) Second Amended and Restated Patent and Security Agreement, dated November 22, 2011 and (ii) Second Amended and Restated Trademark and Security Agreement dated November 22, 2011 to correspond to the information provided in Schedule 5.9 to the Second Amended and Restated Credit Agreement.

5. Governing Law and Construction. THE VALIDITY, CONSTRUCTION AND ENFORCEABILITY OF THIS AGREEMENT SHALL BE GOVERNED BY THE INTERNAL LAWS OF THE STATE OF ILLINOIS, WITHOUT GIVING EFFECT TO CONFLICT OF LAWS PRINCIPLES THEREOF, BUT GIVING EFFECT TO FEDERAL LAWS OF THE UNITED STATES APPLICABLE TO NATIONAL BANKS. Whenever possible, each provision of this Agreement and the other Loan Documents and any other statement, instrument or transaction contemplated hereby or thereby or relating hereto or thereto shall be interpreted in such manner as to be effective and valid under such applicable law, but, if any provision of this Agreement, the other Loan Documents or any other statement, instrument or transaction contemplated hereby or thereby or relating hereto or thereto shall be held to be prohibited or invalid under such applicable law, such provision shall be ineffective only to the extent of such

prohibition or invalidity, without invalidating the remainder of such provision or the remaining provisions of this Agreement, the other Loan Documents or any other statement, instrument or transaction contemplated hereby or thereby or relating hereto or thereto.

6. Waiver of Jury Trial. EACH OF THE PARTIES HERETO IRREVOCABLY WAIVES ANY AND ALL RIGHT TO TRIAL BY JURY IN ANY LEGAL PROCEEDING ARISING OUT OF OR RELATING TO THIS AGREEMENT.

7. Counterparts. This Agreement may be executed in any number of counterparts, all of which taken together shall constitute one and the same instrument.


