The terms of this Assignment are subject to the terms of that certain Asset Purchase Agreement dated November 6, 2015 (the "Controlling Agreement"). This Assignment is not intended to alter the rights or obligations of the parties as set forth in the Controlling Agreement. In the event of any inconsistencies between the terms of this Assignment and the terms of the Controlling Agreement, the parties hereto agree that the terms of the Controlling Agreement shall control.
