#### **PARTIES**

- (1) **LORNAMEAD ACQUISITIONS LIMITED** incorporated and registered in England with company number 05279065 whose registered office is at Sabre House 377-399 London Road Camberley Surrey GU15 3HL (Assignor).
- (2) **WIPRO CYPRUS LIMITED** incorporated and registered in Cyprus whose registered office is at 10 Dionisious Street Alphamega Akropolis Building 3<sup>rd</sup> Floor Office 401 2024 Nicosia Cyprus (Assignee).

#### **BACKGROUND**

- 2.2 The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this agreement or its subject matter or formation (including non-contractual disputes or claims).
