INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement (“*Intellectual Property Security Agreement*”), dated as of December 26, 2015, is made by PRINTRONIX, LLC, a Delaware limited liability company (“*Grantor*”), in favor of SILICON VALLEY BANK (“*Bank*”) pursuant to that certain Credit Agreement, dated as of September 13, 2013, as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, among Pioneer Holding Corp., a Delaware corporation (“*Holdings*”), Printronix, Inc., a Delaware corporation (the “*Existing Borrower*”), the banks and other financial institutions or other entities from time to time parties to the aforementioned Credit Agreement, and Bank (the “*Credit Agreement*”) as modified pursuant to that certain Joinder Agreement dated December 26, 2015 by and among Grantor, Existing Borrower, Bank, and JP Morgan Chase Bank, N.A., (the “*Joinder*”). Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Credit Agreement.

RECITALS

A. Pursuant to the Credit Agreement (as modified by the Joinder), Bank agreed to extend credit to Grantor in the amounts and manner set forth in the Credit Agreement. Bank is willing to extend such credit only upon the condition, among others, that Grantor grant to Bank a security interest in certain Copyrights, Trademarks and Patents to secure the Obligations (as defined in the Guarantee and Collateral Agreement (as defined below)).

B. Pursuant to the terms of that certain Guarantee and Collateral Agreement among Borrower, Holdings, Bank and the other parties from time to time made party thereto as Guarantors, dated as of September 11, 2013 (the “*Guarantee and Collateral Agreement*”), Grantor has granted to Bank a security interest in all of Grantor’s right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Pledged Collateral (as defined in the Guarantee and Collateral Agreement).

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of the Secured Obligations, Grantor hereby represents, warrants, covenants and agrees as follows:

AGREEMENT

To secure its obligations under the Credit Agreement and the other Credit Documents, Grantor hereby grants and pledges to Bank a security interest in all of Grantor’s right, title and interest in, to and under its Intellectual Property (including without limitation those Copyrights, Patents and Trademarks listed on Schedules A, B and C hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.

This security interest is granted in conjunction with the security interest granted to Bank under the Guarantee and Collateral Agreement. The rights and remedies of Bank with respect to the security interest granted hereby are in addition to those set forth in the Credit Agreement, the Guarantee and Collateral Agreement and the other Credit Documents, and those which are now or hereafter available to Bank as a matter of law or equity. Each right, power and remedy of Bank provided for herein or in the Credit Agreement or any of the other Credit Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Bank of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Credit Agreement or any of the other Credit Documents, or now or hereafter existing at law or in equity, and shall not preclude the simultaneous or later exercise by any person, including Bank, of any or all other rights, powers or remedies.

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE INTERNAL LAW OF THE STATE OF CALIFORNIA, WITHOUT GIVING EFFECT TO CONFLICTS OF LAW PRINCIPLES.


