RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is made as of this 23rd day of December, 2015, by THE BRAND BANKING COMPANY (“Lender”), in favor of ACCESS INSURANCE HOLDINGS, LLC, a Georgia limited liability company (the “Company”).

WHEREAS, the Lender has agreed to terminate and release its Lien on and security interest in all the Trademark Collateral Provided therein

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Lender hereby unconditionally and expressly releases, terminates, and extinguishes its Lien on and security interests in all of it’s right, title and interest in, to and under the following Collateral:

- (a) all if the Company’s Trademarks and all Trademark Licenses providing for the grant by or to the Company of any right under any Trademark, including those referred to on Schedule A attached hereto;
- (b) all renewals and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(d) all income, royalties, proceeds and Debt at any time due or payable or asserted under and with respect to any of the foregoing, including all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

The Lender consents and agrees to execute and deliver, at the request and cost of the Company, such further instruments, documents and release forms as the Company may reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon such trademarks.
