RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST is made effective as of December 26, 2015, by and from SILICON VALLEY BANK, as Administrative Agent for the Lenders (the "Administrative Agent") to PRINTRONIX, INC., a Delaware corporation (the "Grantor") as follows:

NOW THEREFORE, the Administrative Agent hereby releases any security interest it may have in the Trademarks, including any goodwill of the business symbolized by the foregoing and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Grantor.
