**Third:** The Agreement and Plan of Merger has been approved and executed by each of the constituent entities.

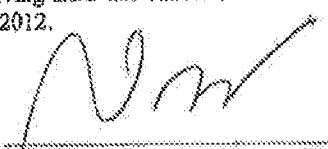
**Fourth:** The name of the Surviving LLC is Spindrift Beverage Co., LLC.
