DECLARATION OF ERIK E. MAURER

UNDER 37 C.F.R. §§ 2.20

I, Erik E. Maurer, declare that:

1. I am Chairman of the Board and Secretary of Superior Tool Corporation ("the Corporation"), current owner of U.S. Trademark Registrations for SUPERIOR TOOL (STYLIZED), U.S. Trademark Registration No. ,1,581,111; DRAINSTICK, U.S. Registration No. 2,739,928; NO BARRIERS TO BUY, U.S. Registration No. 2,038,372; and NEIGHBORHOOD MANUFACTURING, U.S. Registration No. 2,535,596 (collectively, "the Trademarks"), and have personal knowledge of the facts recited herein.

2. The Trademarks are subject to that certain Security Agreement recorded at Reel/Frame No. 003030/0570 ("Security Interest"), in favor of Roynat Business Capital, Inc. ("Roynat") executed December 30, 2004, and recorded February 8, 2005;

3. On April 27, 2009, Roynat issued a Confirmation of Loan Retirement confirming that Roynat had been paid in full by the Corporation as of April 27, 2009, and that the Corporation had no further obligations to Roynat (see letter attached hereto as Exhibit A).

4. Pursuant to the Confirmation of Loan Retirement, the Corporation respectfully requests that the U.S. Trademark Office record a Release of Security Interest in favor of the Corporation as against Roynat in connection with the Trademarks.

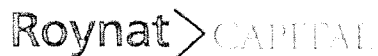
