## TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") is made effective as of December 22, 2015, by and from Script Relief LLC, a Delaware limited liability company (the "Grantor"), to and in favor of Catamaran PBM of Illinois, Inc., a Delaware corporation, as Lender (the "Lender").

WHEREAS, the Grantor has entered into a Pledge and Security Agreement dated as of December 22, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement", pursuant to which the Grantor granted to the Lender a security interest in the Trademark Collateral (as defined below).

WHEREAS, pursuant to the Security Agreement, the Grantor agreed to execute and deliver this Trademark Security Agreement in order to record the security granted to the Lender with the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) Definitions. All capitalized terms not defined herein shall have the respective meaning given to them or given to them by reference in the Security Agreement.

2) The Security Interest.

(a) The Grantor hereby pledges and grants to the Lender a security interest in all of such Grantor's right, title and interest, wherever located and whether now owned or held or hereafter acquired, in and to the following property (collectively, the "Trademark Collateral"), to secure the prompt and complete payment and performance of the Obligations: (i) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, and other indicia of origin or source identification, whether registered or unregistered, and all registrations and applications for registration thereof, including those listed on Schedule A hereto; (ii) the goodwill of the business connected with the use of and symbolized by any of the foregoing; (iii) all renewals of the foregoing; (iv) the right to sue or otherwise recover for past, present, and future infringements, dilution, or other violation thereof; (v) all proceeds of the foregoing, including license fees, royalties, income, damages, claims and proceeds of suit and other payments now or hereafter due and/or payable with respect thereto; and (vi) all other rights of any kind accruing thereunder or pertaining thereto throughout the world.

3) Security Agreement Controls. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Lender pursuant to the Security Agreement, and the Grantor hereby acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

4) Governing Law. THIS TRADEMARK SECURITY AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK WITHOUT REGARDS TO CONFLICTS OF LAWS PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.

5) Recordation. The Grantor hereby authorizes and requests that the Commissioner for Trademarks record this Trademark Security Agreement.


