13 CONSENT OF BESSEMER TRUST  
14 COMPANY OF CALIFORNIA, N.A.  
15 TO SERVE AS TRUSTEE

19 BESSEMER TRUST COMPANY OF CALIFORNIA, N.A. ("BESSEMER") hereby  
20 consents to serve as the sole successor Trustee for the Terry McQueen Testamentary Trust dated  
21 March 19, 1998.

22 BESSEMER acknowledges that Molly McQueen Flattery, in her sole discretion, for any  
23 reason whatsoever, has the absolute discretion to remove BESSEMER as corporate trustee  
24 without the necessity of court approval, and to appoint a successor trustee of her own choosing.

25 BESSEMER may resign at any time. If BESSEMER intends to resign, written notice  
26 shall be given at least forty-five (45) days prior to the effective date of such resignation to (i) any  
27 other then acting trustee, (ii) all beneficiaries then entitled to mandatory or discretionary  
28 distributions from the trust, and (iii) any other person who would be entitled to distribution if the

1 trust were to terminate on the date of the notice. Upon receiving said written notice, Molly  
2 McQueen Flattery, in her sole discretion, shall have the power to appoint a successor trustee of  
3 her own choosing. If Molly McQueen Flattery has not appointed a successor trustee within thirty  
4 (30) days of receipt of said written notice, BESSEMER shall have the right to petition the court  
5 then having jurisdiction over the trust to appoint a successor corporate trustee. Notwithstanding  
6 the foregoing, all trust assets must remain under the control of the resigning corporate trustee  
7 until its resignation becomes effective and the resignation of the corporate trustee shall become  
8 effective only upon the earlier of the date in which a successor trustee has been duly appointed  
9 and consented to act or 120 days from the date reflected on its notice of resignation and  
10 irrespective of the acceptance of the appointment of a successor trustee.
