## RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST

This **RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST**, dated as of December 30, 2015 (the "Release"), is made by **BNP Paribas**, as Administrative Agent for the Lenders (in such capacity, the "Secured Party"), in favor of **Dexter Axle Company** ("Dexter Axle"), **Dexter Marine Products LLC** ("Dexter Marine"), and **Industrial Axle Company, LLC** ("Industrial Axle") (each individually a "Grantor," and collectively, jointly and severally, the "Grantors"). All capitalized terms used in this Release and not otherwise defined herein shall have the meanings assigned to them in the Security Agreement (as defined below).

### WITNESSETH

WHEREAS, the Grantors and Secured Party are parties to that certain Security Agreement dated as of February 28, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, (i) Dexter Axle and Dexter Marine executed the Grant of Trademark Security Interest dated February 28, 2014 and recorded with the U.S. Patent and Trademark Office ("USPTO") on March 7, 2014 at Reel/Frame Nos. 5233/0407 and 5233/0415, (ii) Industrial Axle executed the Grant of Trademark Security Interest dated October 31, 2014 and recorded with the USPTO on November 5, 2014 at Reel/Frame No. 5394/0490, and (iii) Dexter Marine executed the IP Supplement dated November 24, 2015 (the "IP Supplement") and recorded with the USPTO on December 10, 2015 at Reel/Frame No. 5686/0761 (collectively, the "Trademark Security Agreements"), pursuant to which the Grantors granted to the Secured Party a security interest in all Grantors' right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreements);

WHEREAS, the Grantors have requested that the Secured Party release its security interest in the Trademark Collateral in connection with the termination of the Trademark Security Agreements.


