TERMINATION OF TRADEMARK SECURITY INTEREST

This TERMINATION OF TRADEMARK SECURITY INTEREST, dated as of December 31, 2015, (the "Termination") is among Bayside Capital, Inc., in its capacity as the administrative agent pursuant to the Credit Agreement (as defined below) (in such capacity, the "Administrative Agent"), and DC Holdings, LLC (FKA Datastream Content Solutions, LLC), Dolan LLC (FKA The Dolan Company), Finance and Commerce, Inc., Lawyer's Weekly, LLC and Long Island Business News, LLC (individually, each a "Pledgor", and, collectively, the "Pledgors"), as follows:

WITNESSETH

WHEREAS, in connection with (1) that certain Credit Agreement, dated as of June 12, 2014 (as amended, restated, modified and/or supplemented through the date hereof, the "Credit Agreement"), by and among Dolan LLC, a Delaware limited liability company ("Dolan"), as a Borrower and as the Borrowers' Agent, certain Subsidiaries (including each Pledgor) of Dolan from time to time party thereto (together with Dolan, the "Borrowers"), the Lenders from time to time party thereto (the "Lenders") and the Administrative Agent and (2) the Pledge and Security Agreement and Irrevocable Proxy dated as of June 12, 2014 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Collateral Agreement") between the Borrowers and the Administrative Agent, the Pledgors executed and delivered the Trademark Security Agreement dated as of June 12, 2014;

WHEREAS, the Trademark Security Agreement, dated as of June 12, 2014 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") between the Pledgors and the Administrative Agent was recorded with the United States Patent and Trademark Office on November 20, 2014 at Reel/Frame No. 005405/0137 in favor of the Administrative Agent;

WHEREAS, pursuant to that certain payoff letter of the Credit Agreement dated as of the date hereof by and among, *inter alios*, the Administrative Agent, the Lender and the Pledgors, the Administrative Agent released Security Interests on any property of the Pledgors in favor of the Administrative Agent (the "Collateral Release") securing the Obligations, including, without limitation, all Security Interests in each of the Pledgors' right, title and interest in and to the Collateral, including, without limitation, pursuant to the Trademark Security Agreement;

WHEREAS, in connection with such Collateral Release, the Pledgors have requested that the Administrative Agent release its Security Interest in the Trademark Collateral (as defined in the Trademark Security Agreement) and terminate the Trademark Security Agreement.

NOW, THEREFORE, the Administrative Agent, without recourse, representation or warranty and at the Pledgors' sole cost and expense, hereby TERMINATES and RELEASES all of its right, title and interest in and to the Security Interest granted to the Administrative Agent pursuant to the Trademark Security Agreement in the Trademark Collateral, and agrees, confirms and acknowledges that the Trademark Security Agreement shall be terminated. In addition, the Administrative Agent agrees to provide the Pledgors with further information and additional authorization reasonably necessary to evidence such release as may be reasonably requested by the Pledgors.

Capitalized terms used and not defined herein having the meaning assigned to such terms in the Collateral Agreement.


