**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Termination"), is dated as of December 29, 2015 and is made by FIFTH STREET MANAGEMENT LLC, a Delaware limited liability company, acting in its capacity as administrative agent (in such capacity, the "Administrative Agent") under the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of June 30, 2015 made by ALL WEB LEADS, INC., a Delaware corporation (the "Grantor") in favor of the Administrative Agent (the "Trademark Security Agreement"), the Grantor granted to the Administrative Agent a security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached Schedule A (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 30, 2015, at Reel 5565 and Frame 0312; and

WHEREAS, the Grantor has requested, and the Administrative Agent has agreed, to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement and in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Released Collateral.
