**RELEASE OF SECURITY INTEREST**

THIS RELEASE OF SECURITY INTEREST is effective this 4<sup>th</sup> day of December 2015, by and between Jensen Hughes, Inc., ("Jensen") and Manufactures and Traders Trust Company (the "Lender").

WHEREAS, Hughes Associates, Inc., a predecessor in interest to Jensen, entered into a Trademark Security Agreement with Lender, dated December 30 2013, and recorded with the United States Patent and Trademark Office on December 31, 2013, at Reel 5184, Frame 317 (the "First Security Agreement");

WHEREAS, The RJA Group, Inc., a predecessor in interest to Jensen, entered into a Trademark Security Agreement with Lender, dated June 27, 2014, and recorded with the United States Patent and Trademark Office on July 1, 2014, at Reel 5313, Frame 439 (the "Second Security Agreement");

WHEREAS, pursuant to the First Security Agreement and the Second Security Agreement, Jensen and its predecessors in interest granted the Lender a security interest in all its right, title, and interest to its trademarks, including the trademarks listed at **Attachment A** (the "Marks"), among other collateral; and

WHEREAS, the Lender desires to release its security interest in and to the Marks pledged pursuant to the First Security Agreement and the Second Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Lender hereby releases its security interest in and to the Marks and reassigns any and all interests it may have in such Marks to Jensen.
