ITEM 4 – RESTRICTIONS, IF ANY, ON SHARE TRANSFERS

Transfer of Securities Restricted

- 1.1 No shares in the capital of the corporation shall be transferred without the approval of the directors, evidenced by a resolution of the board, and the directors may, in their absolute discretion, decline to register any transfer of shares and shall not be required to disclose their reasons therefor, provided that approval of a transfer of shares may be given as aforesaid after the said transfer has been entered upon the records of the corporation, in which event, unless the said resolution stipulates otherwise, the said transfer shall be valid and shall take effect as from the date of its entry on the books of the corporation; and provided that at such time as any class of shares in the capital of the corporation has been listed for trading on any stock exchange or any regulatory authority has accepted for filing and has issued a receipt for a prospectus qualifying the distribution of such class of shares to the public, or the corporation has in any other manner become a "reporting issuer" within the meaning of the *Securities Act* (British Columbia) or of a *Securities Act* of another jurisdiction, any restriction on the transfer of such class of shares shall, by that fact, be removed.
- 1.2 The corporation's securities, other than non-convertible debt securities, shall not be transferred without either:
 - (a) the sanction of a majority of the directors of the corporation, or
 - (b) the sanction of a majority of the shareholders of the corporation, or alternatively
 - (c) if applicable, the restriction contained in security holders' agreements.

Schedule "B"

ITEM 8 – OTHER PROVISIONS

1. Number of Shareholders

- 1.1 The number of shareholders in the corporation, exclusive of employees and former employees who, while employed by the corporation were, and following the termination of that employment, continue to be, shareholders of the corporation, is limited to not more than 50, two or more persons who are the joint registered holders of one or more shares being counted as one shareholder.
- 1.2 Any invitation to the public to subscribe for securities of the corporation is prohibited.

2. Borrowing

- 2.1 If authorized by by-law which is duly made by the directors and confirmed by ordinary resolution of the shareholders, the directors of the corporation may from time to time:
- (a) borrow money upon the credit of the corporation;
 - (b) issue, reissue, sell or pledge debt obligations of the corporation; and
 - (c) mortgage, hypothecate, pledge or otherwise create a security interest in all or any property of the corporation, owned or subsequently acquired to secure any debt obligation of the corporation.
- 2.2 Any such by-law may provide for the delegation of such powers by the directors to such officers or directors of the corporation to such extent and in such manner as may be set out in the by-law.
- 2.3 Nothing herein limits or restricts the borrowing of money by the corporation on bills of exchange or promissory notes made, drawn, accepted or endorsed by or on behalf of the corporation.

3. Additional Directors

- 3.1 The directors may appoint one or more directors, who shall hold office for a term expiring not later than the close of the next annual general meeting of shareholders, but the total number of directors so appointed may not exceed one third of the number of directors elected at the previous annual general meeting of shareholders.
