**RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS** (this "Release"), is dated as of December 29, 2015 and is made by ROYAL BANK OF CANADA, a bank organized under the laws of Canada, acting in its capacity as administrative agent (in such capacity, the "Agent"), in favor of IQ Holdings, LLC, a Delaware limited liability company ("IQ Holdings"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Grant of a Security Interest in Trademark Rights dated as of August 7, 2013 made by Bankrate, Inc., a Delaware corporation ("Bankrate"), in favor of the Agent (the "Trademark Security Agreement"), Bankrate granted to the Agent a security interest in all of Bankrate's right, title and interest in its Trademarks (including, without limitation, those items listed on Schedule A hereto), (b) all goodwill of the business associated with the Trademarks, and (c) all rights to sue at law or in equity for any infringement other violation or impairment thereof (collectively, the "Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on August 14, 2013, at Reel 5089 and Frame 0612;

WHEREAS, pursuant to that certain Trademark Assignment Agreement dated as of November 13, 2015 (the "Assignment Agreement") made by Bankrate in favor of IQ Holdings, Bankrate assigned to IQ Holdings all of Bankrate's right, title and interest in, to and under the Collateral;

WHEREAS, the Assignment Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 13, 2015, at Reel 5667 and Frame 0803; and

WHEREAS, IQ Holdings has requested, and the Agent has agreed to provide, a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Interest and in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Released Collateral.
