WHEREAS the ASSIGNOR is the registered proprietor of the trademark registrations listed on the attached **Schedule A** (the "Trademarks");


AND WHEREAS the Assignor and Assignee have agreed that the Trademarks shall be assigned and transferred to the Assignee.

NOW THEREFORE THE PARTIES AGREE TO THE FOLLOWING:




