TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “**Release**”) is made as of December 31, 2015, by CHASE CAPITAL CORPORATION, in its capacity as Administrative Agent (“**Administrative Agent**”) in favor of Ohio Medical Corporation, a Delaware corporation and Amvex Corporation, a Delaware corporation (collectively, jointly and severally, “**Grantors**” and each individually “**Grantor**”). Capitalized terms used in this Release but not otherwise defined shall have the respective meaning set forth in the Pledge and Security Agreement (defined below).

WITNESSETH:

WHEREAS, Administrative Agent and the Grantors are parties to that certain Subordinated Pledge and Security Agreement dated November 30, 2011 (the “**Pledge and Security Agreement**”);

WHEREAS, pursuant to the Pledge and Security Agreement, Administrative Agent and the Grantors entered into that certain Trademark Security Agreement, dated as of November 30, 2011 and which was recorded with the Trademark Division of the United States Patent and Trademark Office on December 1, 2011 at Reel 4669, Frame 0220 (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, the “**Trademark Security Agreement**”), pursuant to which the Grantors mortgaged, pledged and hypothecated to the Administrative Agent, and granted to Administrative Agent a security interest in all of such Grantor’s right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired (collectively, the “**Trademark Collateral**”):

- (a) all of its Trademarks and Trademark Intellectual Property Licenses to which it is a party including those referred to on Schedule I hereto;
- (b) all renewals of the foregoing;
- (c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and
- (d) all products and proceeds of the foregoing, including any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademark licensed under any Intellectual Property License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Intellectual Property License;

WHEREAS, the Obligations have been satisfied (other than with respect to contingent indemnification obligations for which no claim has been made) and as such, Administrative Agent now wishes to acknowledge the termination of the Trademark Security Agreement and release all security interests or Liens it may have in, under, or to the Trademark Collateral, and reassign the same to each such Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Release. Administrative Agent acknowledges that the Obligations have been satisfied (other than with respect to contingent indemnification obligations for which no claim has been made) and that the Trademark Security Agreement is hereby terminated. Administrative Agent hereby unconditionally and expressly releases, terminates, extinguishes and waives, its Liens, the security interest granted in the Trademark Security Agreement, and any other interest it may have in, to, or under the Trademark Collateral.
2. Reassignment. Administrative Agent hereby reassigns, grants and conveys to each Grantor, without any representation, recourse or undertaking by Administrative Agent, all of Administrative Agent's right, title and interest in and to the Trademark Collateral of such Grantor.
