**RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Release"), dated as of January 6, 2016, is made by Antares Capital LP, as successor to General Electric Capital Corporation, as collateral agent (in such capacity, the "Agent"), in favor of Arizona Chemical Company LLC, a Delaware limited liability company ("Grantor").

WITNESSETH:

WHEREAS, reference is made to the First Lien Credit and Guarantee Agreement dated as of June 12, 2014 (as amended, restated, supplemented or otherwise modified to date, the "Credit Agreement"), by and among AZ Chem US Inc., as Borrower, Grantor, the other credit parties party thereto, the Lenders from time to time party thereto and the Agent;

WHEREAS, pursuant to the First Lien Pledge and Security Agreement, dated as of June 12, 2014, by and among the Grantor, the other grantors named therein and Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "First Lien Pledge and Security Agreement"), a lien on and security interest in (the "Security Interest") certain collateral, including the Trademark Collateral (as hereinafter defined), was granted by Grantor to the Agent; and for the purpose of recording such Security Interest with respect to the Trademark Collateral with the United States Patent and Trademark Office, the Grantor entered into that certain First Lien Trademark Security Agreement dated as of June 12, 2014, (the "Trademark Security Agreement"), in favor of the Agent;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 12, 2014 at Reel 005301, Frame 0883; and

WHEREAS, the Agent acknowledges full performance of the Grantor's obligations under the Credit Agreement, and accordingly the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral (as hereinafter defined).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby agrees as follows:

1. Definitions. The term "Trademark Collateral", as used herein, shall mean the Trademarks included in the Collateral and secured by the Trademark Security Agreement (including, without limitation, those items listed on Schedule 1 hereto), together with the goodwill associated with the Trademarks. Capitalized terms not defined herein have the meanings set forth in the Credit Agreement and the Trademark Security Agreement.

2. Release of Security Interest. Agent, without representation or warranty and at the Grantor's sole cost and expense, hereby absolutely, unconditionally and irrevocably terminates, cancels, discharges and releases, in its entirety, for the benefit of Grantor and its successors and assigns, any and all of its security interest in and lien on all of Grantor's right, title and interest

in, to and under the Trademark Collateral, and any and all right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.

3. Recordation. Agent authorizes and requests that the Commissioner for Trademarks at the United States Patent and Trademark Office record this Release.

4. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a mutually signed counterpart of this Release.

5. Further Assurances. Agent agrees, upon Grantor's reasonable request, to provide, execute and/or deliver all additional information, authorization and documentation that may be reasonably necessary to effect the release of Agent's security interest in the Trademark Collateral (without representation or warranty and at Grantor's sole cost and expense).

6. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.

7. Miscellaneous. As used in this Release, the word "including" is not intended to be exclusive, or to limit the generality of the preceding words, and means "including, without limitation."
