## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY



WHEREAS, each of the persons listed on Schedule I attached hereto (each individually a “Grantor”, and collectively, the “Grantors”) granted to (i) Esther A. Kurtz, an individual, as successor by assignment to the Estate of David L. Kurtz, (ii) the Grantor Retained Annuity Trust dated as of April 14, 2012, by and among Esther A. Kurtz (the “Settlor”) and David J. Kurtz and Ellen M. Kurtz, as trustees (collectively, the “Trustees”) and (iii) the Grantor Retained Annuity Trust dated as of July 31, 2013, by and among the Settlor and the Trustees, all of the foregoing, collectively, as assignees (the “Assignees”) a security interest in, among other things, certain of the Grantors’ trademarks, including, without limitation, the trademark registrations and applications listed on Schedule II attached hereto (the “Subject Trademarks”) pursuant to a Trademark Security Agreement dated as of February 15, 2012 (the “Agreement”), which was filed at the United States Patent and Trademark Office on March 16, 2012 and recorded on Reel 004737, Frame 0769; and

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Assignees without recourse or warranty hereby (1) release, discharge and relinquish the Assignees’ security interest in the Subject Trademarks, whether granted pursuant to the Agreement or any other agreement or document delivered in connection with the Agreement, (2) reassign to the Grantors all right title, and interest that the Assignees may have had in the Subject Trademarks, including the goodwill associated with the Subject Trademarks, any and all applications or registrations therefor, and the right to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits, whether granted pursuant to the Agreement or any other agreement or document delivered in connection with the Agreement, and (3) acknowledge and agree that any and all right, title or interest of Assignees in any of the Grantors’ intellectual property arising under the Agreement, including the Subject Trademarks, does hereby cease and become void; provided that, nothing contained herein shall constitute a release or discharge of the Assignees’ security interest in any other assets not covered by the Agreement.


