**TERMINATION AND RELEASE OF SECURITY INTEREST COVERING  
TRADEMARKS / PATENTS OWNED BY ROSE AMERICA CORPORATION**

**WHEREAS**, Commerce Bank, (F/K/A Commerce Bank N.A.) (the "Secured Party"), a Missouri bank and trust company, with an address of 1000 Walnut, Kansas City, Missouri, previously was granted a security interest, in and to certain assets and interests of Rose America Corporation, a Kansas corporation located at 3100 S. Meridian Ave, Wichita, KS 67217 (the "Borrower"), specifically the patents and trademarks set forth on **Schedule A** (the "Collateral") attached hereto, by a certain Collateral Assignment and Trademark / Patent Security Agreement executed by Borrower in favor of the Secured Party and effective June 18, 1999 (the "Collateral Agreement"), and recorded with the United States Patent and Trademark Office at Reel/Frame 2055/0323, and as corrected by a recordation at Reel/Frame 3290/0410;

**WHEREAS**, on or prior to the date hereof, Borrower has paid and performed in full with respect to the obligations set forth in the Collateral Agreement and, as such, Secured Party has agreed to release, and terminate its security interest in the Collateral and assign and transfer to Borrower all deeds, assignments and other instruments as may be necessary or proper to reassign and reconvey to re-vest in Borrower the entire right, title and interest to the Collateral as herein provided;

**WHEREAS**, the Secured Party has not assigned any claims or obligations covered by this Release to any other party, and intends that this Release both bind and benefit any successors;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Secured Party hereby releases and terminates the security interest and assigns and transfers to Borrower, without representation, warranty or recourse, all of Secured Party's right, title and interest in and to the Collateral, effective as of the date set forth above.

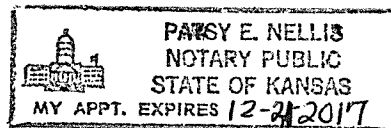
