THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is dated January 7, 2016 by Regions Bank, an Alabama banking corporation ("*Lender*"), with its mailing address at 315 Deaderick Street, 7th Floor, Nashville, Tennessee 37237;

WITNESSETH:
