TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is being executed and entered into as of the last date of execution (the "Effective Date") by and between by JP Ventures, LLC, d/b/a iVape, a South Carolina limited liability company with an address of 2126 Highway 9 E., Suite 7, Longs, South Carolina 29568 ("JP Ventures") and IReady, LLC, a California limited liability company with an address of 2020 Columbia Street, San Diego, California, 92101 ("IReady")

WHEREAS, IReady is the owner of all right, title and interest in and to the federal registration in the United States for the mark IVAPE, which is Registration No. 4,511,030, for "Electric vaporizers" in International Class 11 (the "Assigned Trademark"), together with the goodwill of the business connected with and symbolized by the Assigned Trademark; and

WHEREAS, JP Ventures desires to acquire all right, title and interest in and to the Assigned Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby agree as set forth below.

IReady hereby sells, assigns, transfers and conveys to JP Ventures the entire right, title, interest in and to the Assigned Trademark in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with and symbolized by the IVAPE mark that is the subject of the Assigned Trademark (including, without limitation, the right to renew the Assigned Trademark, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Assigned Trademark, and any priority right that may arise from the Assigned Trademark), the same to be held and enjoyed by

JP Ventures as fully and entirely as such interest could have been held and enjoyed by IReady had this sale, assignment, transfer and conveyance not been made.

IReady authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office to record the transfer of the Assigned Trademark to JP Ventures as assignee of IReady's entire right, title and interest therein.

This Trademark Assignment Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by electronic or facsimile transmission, which transmission shall be deemed delivery of an originally executed document.
