**CERTIFICATE OF MERGER
MERGING INDUSTRIAL ACOUSTICS COMPANY, INC.
WITH AND INTO
THISTLE BIDCO (US) INC.**

Dated as of August 10, 2012

Pursuant to Title 8, Section 252 of the General Corporation Law of the State of Delaware, Thistle Bidco (US) Inc. (the *Corporation*) does hereby certify the following information relating to the merger of Industrial Acoustics Company, Inc. with and into the Corporation:

FIRST: That it is the sole stockholder of Industrial Acoustics Company, Inc., a New York corporation formed under the laws of that state on July 27, 1951.

SECOND: At a meeting of the Board of Directors on 9 August 2012, the Board of Directors duly approved, adopted, certified, executed and acknowledged an agreement and plan of merger, pursuant to Section 252 of the DGCL.

THIRD: The name of the surviving corporation is Thistle Bidco (US) Inc., a Delaware corporation.

FOURTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation, *provided that*, Article First of the certificate of incorporation of the Surviving Corporation shall be amended to read in its entirety as follows:

"The name of the Corporation is Industrial Acoustics Company, Inc."

FIFTH: The merger is to become effective on the filing of this Certificate of Merger with the Secretary of State of the State of Delaware.

SIXTH: The Agreement and Plan of Merger is on file at AEA Investors, L.P., 666 Fifth Avenue, 36th Floor, New York, NY 10022, an office of the surviving corporation.

SEVENTH: A copy of the Agreement and Plan of Merger will be furnished by the surviving corporation on request, without cost, to any stockholder of the constituent corporations.
