FULL RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY

Reference is hereby made to that certain Intellectual Property Security Agreement (the "IP Security Agreement") dated as of October 5, 2011 by and between Bruce R. Cohn, an individual (the "Grantor") and Bank of the West (the "Bank"). The IP Security Agreement was recorded with the United States Patent and Trademark Office, and pursuant to which the Grantor assigned and granted to the Bank, a security interest in and to the Collateral (as such term is defined in the IP Security Agreement), including the registered trademarks specifically listed on Annex 1 attached hereto (the "Marks").

WHEREAS, pursuant to an Assignment Agreement dated as of December 16, 2013 between the Grantor and B.R. Cohn Winery, Inc. ("Winery, Inc."), the Grantor transferred, conveyed and assigned all of his right, title and interest in, to and under the Marks (together with all other rights described therein) to Winery, Inc., subject to the continuing security interest of the Bank;

WHEREAS, on December 17, 2013 Winery, Inc., converted to a California limited liability company named "B.R. Cohn Winery, LLC" (hereinafter, "Winery, LLC");

WHEREAS, the Bank wishes to terminate the IP Security Agreement and release to Winery, LLC, all of the Bank's right, title and interest in and to the Collateral as security for the obligations described in IP Security Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged: the Bank hereby terminates the IP Security Agreement and releases to Winery, LLC, without representation or warranty, all of the Bank's right, title and interest in and to the Collateral as security for the obligations described in the IP Security Agreement; and the Bank hereby authorizes all applicable government officers to record this termination and release, including but not limited to recording the termination and release of the Bank's security interest in the Collateral as security for the obligations described in the IP Security Agreement.

This release shall be construed under and governed by the laws of the State of California and may be executed in any number of counterparts and by different parties on separate counterparts. Delivery of an executed counterpart of this release by telefacsimile or other electronic method of transmission shall be equally effective as delivery of an original executed counterpart of this release.

IN WITNESS WHEREOF, the Bank has executed this Full Release of Security Interest in Intellectual Property as of this 5 day of January, 2016.
