RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST dated as of January 11, 2016, is made by Wells Fargo Bank, a national banking association (successor-by-merger to Wachovia Bank, National Association) as administrative agent and collateral agent ("Agent").

WHEREAS, (i) Agent and TransMontaigne LLC (formerly TransMontaigne Inc.), a Delaware limited liability company ("TransMontaigne") were parties to that certain Notice of Grant of Security Interest in Trademarks dated as of February 28, 2008 and entered into pursuant to that certain Security Agreement, dated as of February 28, 2008 (the "2008 Security Agreement") and recorded in the United States Patent and Trademark Office ("PTO") on March 7, 2008 at Reel/Frame 3734/0766 against the trademarks identified on Schedule I attached hereto (the "First Notice"), (ii) Agent and TransMontaigne Product Services LLC (formerly TransMontaigne Product Services, Inc.), a Delaware limited liability company ("TPSI") were parties to that certain Notice of Grant of Security Interest in Trademarks dated as of February 28, 2008 and entered into pursuant to the 2008 Security Agreement and recorded in the PTO on March 7, 2008 at Reel/Frame 3734/0771 against the trademarks identified on Schedule I attached hereto (the "Second Notice") and (iii) Agent and TransMontaigne were parties to that certain Notice of Grant of Security Interest in Trademarks dated as of December 16, 2009 and entered into pursuant to that certain Amended and Restated Security Agreement, dated as of December 16, 2009 (the "2009 Security Agreement"), and recorded in the PTO on December 17, 2009 at Reel/Frame 4115/0676 (the "Third Notice") against the trademarks identified on Schedule I attached hereto. TransMontaigne and TPSI, together with all other grantors under the 2008 Security Agreement and the 2009 Security Agreement, are collectively referred to herein as "Grantor".

WHEREAS, the 2008 Security Agreement, the 2009 Security Agreement, and the First Notice, Second Notice and Third Notice granted, assigned and conveyed to Agent a security interest in each applicable Grantor's entire right, title and interest in and to certain intellectual property collateral (as defined in the 2008 Security Agreement and the 2009 Security Agreement, including, without limitation all of the United States trademarks listed on Schedule I (the "Trademarks").

WHEREAS, pursuant to that certain pay-off letter, dated June 30, 2014 Agent confirmed, effective as of July 1, 2014: (i) payment of all outstanding obligations of Grantors, (ii) termination and release of all security interests made by Grantors to Agent, and (iii) upon the written request and at the sole cost of Grantors, Agent will promptly execute and deliver any and all further instruments and documents and take such further action as Grantors may reasonably request to effectuate, evidence or reflect of public record, the release of the security interests referred to in such pay-off letter.

WHEREAS, Agent desires to confirm its release of its rights and security interests in all intellectual property collateral, including the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally releases and terminates (i) its

security interest and other rights in, to and under the intellectual property collateral, including, without limitation, all of the Trademarks listed on Schedule I and (ii) any and all other rights it may have under the 2008 Security Agreement, the 2009 Security Agreement, the First Notice, the Second Notice and the Third Notice.
