**SECOND AMENDED AND RESTATED
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **SECOND AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT** is entered into as of January 12, 2016 by and between **AGILITY CAPITAL II, LLC** ("Lender") and **TRUEVISION SYSTEMS, INC.**, a Delaware corporation ("Grantor").

RECITALS

Lender and Grantor are parties to that certain Amended and Restated Intellectual Property Security Agreement dated as of July 7, 2014 (the "Restated Agreement"). In connection with that certain Loan Agreement between Lender and Grantor dated as of the date hereof (the "Loan Agreement"), Lender and Grantor desire to amend and restate the Restated Agreement as set forth herein.

NOW, THEREFORE, Grantor agrees as follows:

AGREEMENT

This Agreement is intended to and does completely amend and restate, without novation, the Restated Agreement. All security interests granted under the Original Agreement are hereby confirmed and ratified and shall continue to secure performance of Grantor's obligations under the Loan Agreement. In connection herewith, Grantor grants to Lender a security interest in all of Grantor's right, title and interest in Grantor's intellectual property (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C hereto), including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits). This security interest is granted in conjunction with the security interest granted to Lender under the Loan Agreement. Each right, power and remedy of Lender provided for herein shall not preclude the simultaneous or later exercise by Lender of any or all other rights, powers or remedies.
