**TRADEMARK ASSIGNMENT**

THIS ASSIGNMENT (this "Assignment"), dated as of December 22, 2015, is by and among Little Woodrow's Holdings – LW2, LLC ("LWH – LW2"), a Texas limited liability company having a principal place of business at 3711 Briar Park, Suite 300, Houston, Texas 77042, LW3, LLC ("LW3"), a Delaware limited liability company having a principal place of business at 3711 Briar Park, Suite 300, Houston, Texas 77042, 2LW, LLC ("2LW"), a Delaware limited liability company having a principal place of business at 3711 Briar Park, Suite 300, Houston, Texas 77042 and Little Woodrow's, LLC ("Little Woodrow's"), a Delaware limited liability company having a principal place of business at 3711 Briar Park, Suite 300, Houston, Texas 77042.

**RECITALS**

WHEREAS, LWH – LW2 is the owner of those certain trademarks and the associated U.S. Trademark Registrations and Applications for the Marks identified at Schedule A (collectively the "Marks");

WHEREAS, LW3 desires to (i) obtain for itself all right, title and interest that LWH – LW2 may have in and to the Marks and (ii) in turn assign such right, title and interest to 2LW;

WHEREAS, 2LW desires to (i) obtain for itself all right, title and interest that LW3 may have in and to the Marks and (ii) in turn assign such right, title and interest to Little Woodrow's; and

WHEREAS, Little Woodrow's desires to obtain for itself all right, title and interest that 2LW may have in and to the Marks.

NOW, THEREFORE, in consideration of the foregoing and of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto promise and agree as follows:

1. Assignments.

- (a) LWH – LW2 hereby assigns to LW3 its entire right, title and interest in and to the Marks.
- (b) Immediately on obtaining all right, title and interest in and to the Marks from LWH – LW2, LW3 hereby assigns to 2LW its entire right, title and interest in and to the Marks.
- (c) Immediately on obtaining all right, title and interest in and to the Marks from LW3, 2LW hereby assigns to Little Woodrow's its entire right, title and interest in and to the Marks.
- (d) The parties acknowledge and agree that each of the foregoing assignments shall include the goodwill of the business symbolized by the Marks and the

registrations for the Marks, and includes all common-law and other rights in the Marks, all claims, demands, and causes for action, both at law and in equity, that assignor may have, or may hereafter acquire, on account of any infringement of the Marks prior to the date hereof, and does hereby empower assignee, and its successors in interest, to sue for and collect the same, to its and their own absolute use.

2. Further Assurances. Each party hereby agrees from time to time after delivery of this Assignment to do, execute, acknowledge and deliver or to cause to be done, executed, acknowledged and delivered such further transfers, assignments, conveyances and assurances as may be reasonably requested by the other party in order to effect the full assignment, transfer and assumption, as applicable, of the Marks as set forth herein.

3. Waivers. None of the provisions in this Assignment may be waived, changed or altered except in a writing signed by all of the parties hereto.

4. Governing Law. THIS AGREEMENT IS GOVERNED BY AND SHALL BE CONSTRUED IN ACCORDANCE WITH THE LAW OF THE STATE OF TEXAS, WITHOUT REGARD TO THE CONFLICTS OF LAW PRINCIPLES OF SUCH STATE.

5. Counterparts; Facsimile. This Assignment may be executed in one or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. This Assignment may be executed and delivered by facsimile transmission or by electronic mail, and a facsimile or electronic copy of this Assignment or of a signature of a party will be effective as an original.
