## CONFIRMATORY AND RESTATED CHANGE OF NAME

**THIS CONFIRMATORY AND RESTATED CHANGE OF NAME** (hereinafter the “**Change of Name**”) is made by UDA, LLC (f/k/a ListenLogic LLC and Akuda Labs LLC), a Delaware limited liability company (hereinafter the “**Trademark Owner**”).

### WITNESSETH:

**WHEREAS**, on or about December 28, 2007, ListenLogic LLC, a Delaware limited liability company, was formed;

**WHEREAS**, on or about January 29, 2013, ListenLogic LLC filed United States Trademark Application Serial No. 85/835,385 in the United States Patent and Trademark Office (hereinafter the “**Trademark Application**”) for the registration of the trademark “ListenLogic” (hereinafter the “**Trademark**”);

**WHEREAS**, the Trademark Application inadvertently identified ListenLogic LLC as a Pennsylvania limited liability company;

**WHEREAS**, during the pendency of the Trademark Application and thereafter, ListenLogic LLC also did business under, and has been known by, the names “Akuda Labs LLC” and “ListenLogic”;

**WHEREAS**, on or about November 27, 2013, ListenLogic LLC erroneously, and in good faith, recorded in the United States Patent and Trademark Office at Reel 5163, Frame 0044, a document entitled “Certificate of Amendment of Registration – Foreign submitted to the Pennsylvania Department of State” purportedly changing the name of ListenLogic LLC to Akuda Labs LLC (hereinafter the “**Attempted Change of Name**”);

**WHEREAS**, on or about April 8, 2014, the Trademark Application issued as United States Trademark Registration No. 4,509,139 in the name of Akuda Labs LLC (Pennsylvania Limited Liability Company); and

**WHEREAS**, on or about August 5, 2015, ListenLogic LLC changed its corporate name to UDA, LLC by way of a Certificate of Amendment to the Certificate of Formation of ListenLogic LLC (hereinafter the “**Amendment to the Certificate of Formation**”), a copy of which is attached hereto as Exhibit A).

**NOW, THEREFORE**, UDA, LLC hereby confirms the following:

1. The Trademark has been continuously owned, used, and controlled by Trademark Owner since at least as early as the formation of ListenLogic LLC on or about December 28, 2007;

2. On or about January 29, 2013, Trademark Owner filed the Trademark Application in the United States Patent and Trademark Office inadvertently identifying the Applicant as a Pennsylvania limited liability company rather than a Delaware limited liability company.

3. On or about the November 27, 2013, the Attempted Change of Name was erroneously, and in good faith, recorded in the United States Patent and Trademark Office at Real 5163, Frame 0044.

4. A true and correct copy of the Amendment to the Certificate of Formation changing Trademark Owner's corporate name from Listen Logic LLC, a Delaware limited liability company, to UDA, LLC, a Delaware limited liability, is attached hereto as Exhibit A.
