RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of January 13, 2016 (“Effective Date”) by EMPOWER CONDUIT LLC, a Delaware limited liability company (the “Secured Party”), in favor of EMPOWER SOFTWARE SOLUTIONS, INC., a Delaware corporation (“Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Collateral Assignment and Security Agreement, entered into by Grantor in favor of CHATHAM CREDIT MANAGEMENT III, LLC, a Georgia limited liability company (“Chatham”), dated as of January 25, 2011 (the “Trademark Security Agreement”), Grantor granted to Chatham a security interest in and to all of Grantor’s right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement), including all of the Trademarks (as defined in the Trademark Security Agreement) set forth on Exhibit A (the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on February 18, 2011, at Reel 4482, Frame 0347;

WHEREAS, pursuant to the terms and conditions of that certain Appointment of Successor Agent, entered into by and between Chatham and the Secured Party, dated as of January 24, 2014 (the “Trademark Security Agreement”), Chatham assigned to the Secured Party all of its rights, remedies, duties, and obligations with respect to, and its security interest under, the Collateral, including the Trademark Collateral; and

WHEREAS, the Appointment of Successor Agent was recorded with the PTO on March 3, 2014, at Reel 5228, Frame 0472.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates the Trademark Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral.

The Secured Party shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.
