ASSIGNMENT

THIS ASSIGNMENT is made the 18th day of August 2015

- 1.3 together with the right to apply for prosecute and obtain any further applications for registered trade marks or similar protection or claim priority from the Trade Marks throughout the world in the intent that the resulting grant of any registered trade mark shall be in the name of and vest to the Assignee

(2) The Assignor confirms that this Assignment is made with the goodwill attaching to the Trade Marks


