ASSIGNMENT AGREEMENT

This ASSIGNMENT AGREEMENT, effective January 5, 2016, is made by and between MP Marks, LLC, a Delaware limited liability company having a place of business at 6597 Nicholas Boulevard, Cap Ferrat, PH 11, Naples FL 34108 ("ASSIGNEE"), and Marco's Franchising, LLC, an Ohio limited liability company having a place of business at 5252 Monroe St., Toledo, OH 43623 ("ASSIGNOR").

WHEREAS, ASSIGNOR is the owner of the marks set forth below and the goodwill of the business symbolized thereby and associated therewith, which mark was embodied by registration in the United States Patent and Trademark Office (referred to as "the Mark");

WHEREAS, ASSIGNEE is desirous of acquiring the Mark, and of recording its status as owner of the entire right, title, and interest in and to the Mark;


NOW, THEREFORE, for the good and valuable consideration as set forth in a separate agreement between the parties, receipt of which is hereby acknowledged, the parties agree as follows:

1. ASSIGNOR does hereby assign, transfer, and convey to ASSIGNEE all its right, title, and interest in and to the Mark, inclusive of the goodwill of the business symbolized by the Mark, and the trademark registration associated therewith as encompassed by the defined term "the Mark," including, but not limited to, using the Mark in ASSIGNOR trade names and corporate names.
2. ASSIGNEE hereby assumes all liabilities and obligations in connection with the assignment described in Paragraph (1) hereof, except as otherwise agreed in writing by the parties.
3. ASSIGNOR agrees to take whatever further action is deemed necessary or appropriate by ASSIGNEE to properly and fully effect and perfect the transfer to ASSIGNEE of the Mark, to establish full custody of the Mark by ASSIGNEE, to set forth and establish the chain of title to the Mark, and to set forth and establish the first use of the Mark. For example, without limitation, ASSIGNOR agrees to execute assignments to ASSIGNEE regarding the Mark as may be required in proceedings throughout the world.
4. This Assignment Agreement shall be governed by the internal laws of the State of Florida, without reference to its conflicts of law principles.

IN WITNESS WHEREOF, the parties have executed this Agreement by and through their properly authorized signatories effective as of the date indicated above.


