TRADEMARK ASSIGNMENT AGREEMENT

This trademark assignment agreement ("AGREEMENT") is made effective as of the 13th day of January 2016 ("Effective Date") by and between Atkinson-McDougal LLC, an Oregon limited liability company with a place of business at 24902 Evergreen Road, Philomath, Oregon 97370 (hereinafter referred to as "ASSIGNOR") and Contech Engineered Solutions LLC, an Ohio limited liability company with a principal place of business at 9025 Centre Pointe Drive, Suite 400, West Chester, OH 45069 (hereinafter referred to as "ASSIGNEE").

WHEREAS, prior to the Effective Date, Assignee has used the trademark A-JACKS in the United States and Canada as a licensee of Assignor, and desires now to own the exclusive trademark rights to the trademark A-JACKS in the United States and Canada;

WHEREAS, under the terms of this Agreement, Assignor agrees to assign to Assignee all its rights, titles and interests to the trademark A-JACKS in the United States and Canada, but in no other country or jurisdiction;


NOW, THEREFORE, for good and valuable consideration as agreed to by the parties, the receipt and adequacy of which are hereby acknowledged, the parties intending to be legally bound by this Agreement hereby agree as below:

Assignor hereby assigns, transfers and conveys to Assignee, and Assignee hereby receives and accepts, Assignor's entire rights, titles, interests in the trademark A-JACKS in the United States and Canada (but in no other countries or jurisdictions outside the United States and Canada in which Assignor owns any rights in the trademark A-JACKS), along with the goodwill attached to the business connected with and symbolized by the A-JACKS trademark in the United States and Canada, including, without limitation, U.S. Trademark Reg. No. 1,949,179, the right to renew or file any future registrations of the A-JACKS trademark in the United States and Canada, and any U.S. or Canadian common law rights in the trademark A-JACKS possessed by Assignor, the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this assignment, transfer and conveyance not been made.

IN WITNESS WHEREOF, the Assignor and Assignee have each caused this Agreement to be duly executed and effective as of the Effective Date first above written.


