Pursuant to Section 242 of the General Corporation Law of the State of Delaware, the undersigned, being an authorized officer of Health Grades, Inc., a Delaware corporation (the "Company"), does hereby certify the following:

**FIRST:** The name of the Company is Health Grades, Inc.

**SECOND:** The original Certificate of Incorporation of the Company was filed with the Secretary of State of Delaware on December 22, 1995 under the corporate name Specialty Care Networks, Inc.

**THIRD:** The Certificate of Incorporation of the Company is hereby amended to change Article One thereof, relating to the name of the Company. Accordingly, Article One of the Certificate of Incorporation shall be amended to read in its entirety as follows:
