RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this “Release”) is made as of January 15, 2016 by SILICON VALLEY BANK (in such capacity, the “Bank”).

W I T N E S S E T H:

WHEREAS, SIDECAR TECHNOLOGIES, INC., SIDE.CR, LLC and GOROODA LLC (the “Grantors”) each executed that certain Loan and Security Agreement, dated as of December 11, 2013, and each Grantor executed that certain Intellectual Property Security Agreement, dated as September 24, 2015 (together, as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), in favor of the Bank, pursuant to which the Grantor granted a security interest to the Bank in certain trademarks and other intellectual property of Grantor; and

WHEREAS, in connection with said Security Agreement, documentation was recorded with the United States Patent and Trademark Office at Reel 5642 and Frame 0451 on October 9, 2015; and

WHEREAS, the Bank has agreed to release all its liens on the trademarks and trademark applications of the Grantor identified on Exhibit A attached hereto and made a part hereof (the “Released Collateral”), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Bank hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of the Bank’s right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
