WHEREAS, Assignee is desirous of acquiring the Mark and Assignor is willing to assign the Mark to Assignee pursuant to the terms of this Assignment.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor hereby assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in and to the Mark, in the United States and elsewhere, including the right to sue for past infringement, together with the goodwill associated with the Mark.
2. Further Assurances. Assignor shall execute and deliver to Assignee such other documents and assignments as may be necessary to consummate or implement this Assignment. Assignee shall be responsible for recording this Assignment with the United States Patent and Trademark Office.
3. Binding Effect. This Assignment shall be binding upon and shall inure to the benefit of the Parties, and their respective successors and assigns.


