**(TRADEMARKS)**

WHEREAS, GLOBAL WEST COMMUNICATIONS, INC., a California corporation d/b/a eMOBUS (herein referred to as "Grantor"), has adopted, used and is using the trademarks listed on the annexed Schedule 1 annexed hereto as part hereof, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks");




