RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of January 15, 2016 (the "Effective Date"), is made by BANK OF AMERICA, N.A., in its capacity as Collateral Agent (in such capacity, the "Collateral Agent"), and as successor, in such capacity, to ROYAL BANK OF CANADA (the "Prior Collateral Agent") and as successor, in such capacity to MORGAN STANLEY & CO. LLC (the "Subsequent Collateral Agent") and as successor, in such capacity, to MORGAN STANLEY & CO. INCORPORATED (the "Original Collateral Agent"), in favor of the grantor parties identified on the signature page hereto (the "Grantors").

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of November 2, 2010, by and among the Collateral Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Guarantee and Collateral Agreement"), the Grantors granted to the Collateral Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantors executed and delivered the Trademark Security Agreement dated as of January 11, 2011, as supplemented by the Supplemental Trademark Security Agreement dated as of October 26, 2011, the Trademark Security Agreement dated as of November 25, 2013 and the Trademark Security Agreement dated as of March 7, 2014 (the "Original Trademark Security Agreements");

WHEREAS, the Original Trademark Security Agreements were recorded with the United States Patent and Trademark Office on February 11, 2011 at Reel/Frame 4477/0137 and on November 11, 2011 at Reel/Frame 4659/0652;

WHEREAS, the Original Collateral Agent resigned and was replaced by the Subsequent Collateral Agent;

WHEREAS, pursuant to the terms of the Successor Agent Agreement, dated March 18, 2014, the Subsequent Collateral Agent resigned and was replaced by the Prior Collateral Agent;

WHEREAS, pursuant to the terms of the Successor Agent Agreement, dated March 31, 2015, the Prior Collateral Agent resigned and was replaced by the Collateral Agent;

WHEREAS, the Grantors executed and delivered a Notice of Succession of Agency, dated as of April 2, 2015 (the "Notice of Succession of Agency"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Notice of Succession of Agency was recorded with the United States Patent and Trademark Office on April 3, 2015 at Reel/Frame 5492/0196;


WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantor executed and delivered a Trademark Security Agreement, dated as of April 21, 2015 and a Trademark Security Agreement, dated as of April 28, 2015 (the "Trademark Security Agreement Supplements" and, together with the Original Trademark Security Agreements, the "Trademark Security Agreements"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement Supplements were recorded with the United States Patent and Trademark Office on April 22, 2015 at Reel/Frame 5502/0204 and on April 29, 2015 at Reel/Frame 5506/0334;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Guarantee and Collateral Agreement, the Notice of Succession of Agency or the Trademark Security Agreements, as applicable.
2. Release. The Collateral Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth Schedule A attached hereto, arising under the Guarantee and Collateral Agreement, the Notice of Succession of Agency and the Trademark Security Agreements. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral under the Notice of Succession of Agency or Trademark Security Agreements, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.
3. Termination. The Collateral Agent, without representation or warranty of any kind, terminates and cancels the Notice of Succession of Agency and the Trademark Security Agreements.
4. Further Assurances. The Collateral Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by each Grantor, at such Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
