RELEASE OF SECURITY INTEREST IN TRADEMARKS

L.P., an Israeli limited partnership ("Plenus III (C.I.)"; together with Plenus II, Plenus II (D.C.M.), Plenus III, Plenus III (D.C.M.), and Plenus (2), the "Grantee"), all with offices located at 16 Abba Eben Blvd., Herzliya Pituach, Israel, in favor of cVidya Networks Inc., a Delaware corporation, with an address at 24 Raul Wallenburg St., Tel Aviv 69719, Israel ("Grantor").

WHEREAS, pursuant to the Amended and Restated Security Agreement, by and among the Grantor and the Grantee, dated as of January 7, 2010 (as amended, restated, supplemented or otherwise modified and in effect from time to time (the "Security Agreement"), Grantor granted to Grantee a continuing security interest in: (i) all of the Grantor's right, title and interest in, to and under, among others, the trademarks and trademark registrations (the "Grantor's Marks") including but not limited to those set forth on Schedule A, attached hereto and made a part hereof, (ii) all proceeds and products of the Grantor's Marks; (iii) the goodwill of the business with which the Grantor's Marks are associated, and (iv) all causes of action arising prior to or after the date thereof for infringement of any of the Grantor's Marks or unfair competition regarding the same.

WHEREAS, Grantee hereby confirms that the security interest in the Grantor's Marks has been discharged, terminated and released in all respects.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which the parties hereby acknowledge:

1. Grantee hereby (1) releases, discharges and relinquishes its security interest in all of the Grantor's Marks, including, without limitation, those identified on Exhibit A, annexed hereto and made a part hereof, and (2) reassigns to Grantor all right, title and interest that Grantee may have had in the Grantor's Marks, including all goodwill associated with the Grantor's Marks, all proceeds and products of the Grantor's Marks and all causes of action for infringement of any of the Grantor's Marks or unfair competition regarding the same.

2. Grantee specifically acknowledges that the Security Agreement is no longer effective, including with respect to the Grantor's Marks, and that Grantee does not own any rights to or have any ownership interest or claim in any of the Grantor's Marks.

3. Grantee acknowledges and confirms that the terms and conditions of this Release shall be effective evidence of the release of the security interest in all Collateral, including the Grantor's Marks, and the termination of the Security Agreement solely with respect to the Grantor's Marks.
