Declaration re Invalidity of Assignment


I, Amy E. Carroll, a partner in the Washington, D.C., U.S.A. office of the law firm of Drinker Biddle & Reath LLP, which serves as trademark counsel for VWR International, LLC attest as follows:

THAT the conveyance of U.S. Registration Nos. 1,015,568 and 1,069,760 recorded at Reel/Frame 002016/0546 ("Assignment 1" – original coversheet attached) is void because Science Kit & Boreal Laboratories, the purported assignee in Assignment 1, never existed as a legal entity and thus could not have held any trademarks or their associated registrations;

THAT Science Kit, Inc., the purported assignor in Assignment 1, remained the owner of U.S. Registration Nos. 1,015,568 and 1,069,760 until assigning its entire interest in the same registrations to Scientific Holdings Corp., a Delaware corporation, on July 1, 2001, as recorded at Reel/Frame 002521/0244; and

THAT the chains of title associated with U.S. Registration Nos. 1,015,568 and 1,069,760 are accurate and complete, with the exception of Assignment 1, which was improperly drafted and recorded.

For the foregoing reasons, the chains of title associated with U.S. Registration Nos. 1,015,568 and 1,069,760 should be corrected to reflect the invalidity of Assignment 1 and the fact that the conveyance noted therein did not occur.
