## REASSIGNMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This REASSIGNMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is executed as of January 15, 2016 by COMERICA BANK, a Texas banking association (the "Assignor") for the benefit of CLINVERSE, INC., a Delaware corporation (the "Assignee"), with its principal executive office located at 4505 Emperor Boulevard, Suite 130, Durham, North Carolina 27703.

### RECITALS

A. WHEREAS, reference is made to that certain Loan and Security Agreement, dated as of March 12, 2015, by and between Assignee and Assignor (as amended, modified, supplemented, or restated, the "Loan Agreement");

B. WHEREAS, pursuant to the Loan Agreement, Assignee executed and delivered that certain Intellectual Property Security Agreement, dated as of March 12, 2015, by and between Assignee and Assignor (as amended, modified, supplemented, or restated, the "IP Security Agreement"), pursuant to which Assignee granted a security interest in all of Assignee's right, title and interest in and to certain Trademarks, including without limitation the Trademarks listed on Exhibit A (all such Trademarks, collectively, the "Trademark Collateral"). As used herein, "Trademark" means any trademark and servicemark right, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Assignee connected with and symbolized by such trademarks, together with all rights and remedies against past, present, and future infringement, misappropriation, or other violation thereof;

C. WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on March 30, 2015 at Reel/Frame 5488/0082;

D. WHEREAS, the Assignor wishes to release and discharge fully its security interest in the Trademark Collateral and reassign to Assignee all interest that Assignor may have in the Trademark Collateral.

### AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby release and discharge fully its security interest in the Trademark Collateral and reassigns to Assignee, without warranty or recourse, all interest of Assignor in and to the Trademark Collateral.

Assignor hereby authorizes Assignee or Assignee's agents or designees to (i) record this Release with the United States Patent and Trademark Office and any foreign intellectual property registrars, or (ii) otherwise file or record this Release as necessary to evidence the Assignor's release and discharge of its security interest in the Trademark Collateral. Assignor further agrees to execute and deliver to Assignee any and all further documents and instruments, and to do any and all further acts which Assignee (or its agents or designees) reasonably requests, at Assignee's cost and expense, in order to confirm this Release and the applicable Assignee's right, title, and interest in the Trademark Collateral.
