WHEREAS, Assignor and Assignee are desirous of confirming said transfer of title in this Assignment of Trademarks for purposes of filing the same with the United States Patent and Trademark Office and other appropriate governmental offices;

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor transferred and assigned effective as of September 30, 2015, and hereby transfers and assigns to Assignee, the Marks and the associated goodwill of the business connected with and symbolized by such Marks, as well as all rights to damages or profits, due or accrued, arising out of past infringement of such Marks or injury to said goodwill and the right to sue for and recover the same in the Assignee's own name.

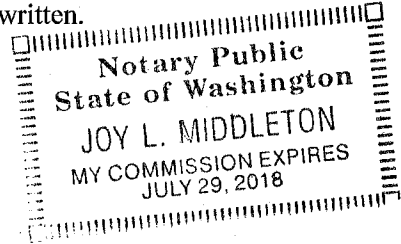
