RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

NORTHSIDE MEDIA GROUP LLC, a Delaware limited liability company ("Grantor"), executed an Intellectual Property Security Agreement dated as of June 19, 2015 in favor of CITY NATIONAL BANK ("Bank") (as amended from time to time, the "Security Agreement").

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Bank, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Released Marks, and retransfers to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Bank, all of Bank's right, title and interest in and to the Released Marks, the goodwill associated therewith, and all causes of action for past infringement, if any.
