RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Trademark Security Agreement (the "Trademark Security Agreement") dated October 17, 2012 and filed on November 5, 2012 in Reel 004894, Frame 0022, the Grantor granted to Secured Party a security interest in the Grantor's entire right, title and interest in and to the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), whether now owned or existing or hereafter created, acquired or arising:

WHEREAS, pursuant to that certain letter dated December [], 2015 by the Secured Party to the Grantor, (a) the obligations secured by said security interest have been paid in full or otherwise satisfied, (b) the Grantor's obligations under the Trademark Security Agreement have terminated, and (c) all liens and security interest securing the Grantor's obligations were fully released without further action.

NOW THEREFORE, for and in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this release, the Secured Party hereby declares that the security interest granted by the Grantor to the Secured Party in the Trademark Collateral is hereby DISCHARGED, RELEASED AND TERMINATED, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Trademark Collateral, effective as of the date set forth above.

This release shall be binding upon Secured Party's legal representatives, assigns and successors.
